2016 PARADE OF HOMES CONTRACT

This contract is between the Builder/Remodeling Contractor and the Home Builders Association of Western Michigan. For the purposes of this Contract, the following definitions apply: "HBAWMI" is the Home Builders Association of Western Michigan; "Committee" is the Parade of Homes Committee of the Home Builders Association of Western Michigan; "Builder/Remodeler" or "Builder/Remodeling Contractor" is any person, firm, or corporation who is a member in good standing of the HBAWMI, has a valid Michigan Builders License, and is participating in the Parade of Homes.

No materials will be accepted unless also accompanied by the Contract and full payment.

The following materials must be submitted with signed Contract and payment:

- a. Map of each Parade home with the location marked and written directions provided.
- b. Information sheet and description of the Remodeled Project.
- c. Signed Commercial property owner contract.
- d. A floor plan, if you would like it to be printed in Parade Guidebook. Format options include DXF, DWG, or JPEG.
- e. Before and After pictures in the formats listed, if available.
- f. Incomplete applications (see list above) will not be accepted. Plans must be in the formats listed. Pictures may be provided in JPEG or PDF formats.
- 1. Every remodeled home entered in the 2016 Parade of Homes must:
- a. Be a major remodeling project
- b. Be completed between April 1, 2015 and June 8, 2016.
- c. Be open and staffed by the Remodeler or their representative for the entire 2016 Parade of Remodeled Homes. Dates and times are noted on the cover page and our website, www.KalamazooHomePage.com.
- 2. For this entry fee, I understand that I will receive:
- a. A full page in the Parade of Homes Guidebook with information about the Remodeled Parade Home.
- b. Marketing and promotional assistance on the HBAWMI web site.
- c. Use of Parade of Homes directional and numbered yard signs. Signs must be returned by **Friday**, **June 24**, **2016**. It is the responsibility of the Remodeler to follow local sign ordinances. (**\$45** will be charged for each unreturned sign.)
- d. Up to 300 pairs of Shoe Covers (should you require additional shoe covers, they will be available for purchase at the HBWMI office, Monday Friday from 8:00 a.m. 5:00 p.m.), and Entrance, Exit, Parents Watch Children, and No Smoking signs.

- with a minimum of one before and one after photo (PDF or JPEG)if available, and a key element of the project for promotional purposes.
- 4. Builder/Remodeler agrees to provide the HBAWMI with the following by midnight on Wednesday, **June 15, 2016**:
- a. Certificate of Liability Insurance, naming HBAWMI as coinsured, with a minimum of \$1,000,000 liability/\$5,000 medical payment.
- b. Certificate of Insurance for the Commercial property owner naming the HBAWMI coinsured.
- 5. Commercial entry must be completed (cleaned and ready for Parade visitors) prior to opening on **June 16**, **2016**.
- a. Floor coverings are required.
- b. The front yard must be landscaped (final grade, top soil raked and seeded, hydro seeded or sodded) and the rear and side yards in the final grade stage.
- c. Driveways, sidewalks, and garages will be free from debris, dumpsters and/or trash containers.
- d. Driveways and sidewalks must be hard surfaced and dust-free (no gravel).
- 6. Builder/Remodeler is responsible for security and parking for their Commercial entry during the Parade. HBAWMI IS NOT RESPONSIBLE FOR SECURITY. For safety purposes and to provide a safe means of ingress and egress, there will be no parking of vehicles or any other items allowed on driveways.
- 7. Each Commercial entry must be opened and staffed by the Builder/Remodeler, or his representatives, during Parade hours. Builder/Remodeler must have property staffed 15 minutes prior to Parade hours and remain onsite until
- closing. Builder/Remodeler is responsible for the actions of their representatives during the Parade.
- 8. HOUSE & GARAGE SET-UP: Remodeler is not responsible for selling tickets or collecting money. The Builder/Remodeler must provide the following:
- a. A table and two chairs in the garage or another area for Non-Profit Organization ticket sellers.
- b. Chairs must be available for visitors to use to put shoe covers on. I understand that I also have the option of requesting that visitors remove their shoes before entry. Shoe covers will be provided by the HBAWMI (up to 300 pair) to Builder/Remodeler at pick up. Service Group is responsible for ordering during the Parade.
- c. On-site bathroom facilities must be made available to volunteers staffing the Builder/Remodeler's entry and ticket sellers. Public restrooms are not required.
- 3. Builder/ Remodeler agrees to furnish the HBAWMI Office

- 9. The official Parade of Commercial Entries letter sign must be used outside your Commercial Parade entry. (Note: Must be placed in accordance with local sign ordinances. See your local government). This sign will be furnished by HBAWMI. In addition,
- a. Builder/Remodeler may use a sign, not to exceed 16 square feet, with their corporate name and phone number on it.
- b. Builder/Remodeler signs may be used prior to the 2016 Parade of Homes.
- c. Signs may be used prior to the Parade of Homes indicating the house is a "Future Parade House".
- d. Beginning the morning of **Thursday, June 16, 2016,** only official Parade signs and Builder/Remodeler's signs may be used.
- e. The participant shall be furnished with directional signs that are to be used to indicate the best way to get to the home from the nearest main road. The Builder/Remodeler participant is also responsible for placement and collection of these signs. Note: Follow local sign ordinances and regulations.
- f. INTERIOR SIGNS: At the Builder/Remodeler's discretion, members in good standing of HBAWMI may place a sign in your Parade entry. If you are unsure if a company is a member, either check www.KalamazooHomePage.com or call the HBAWMI office.
- g. EXTERIOR SIGNS: At the Builder/Remodeler's discretion, vendors with products on the exterior of the property (i.e. landscapers) may have one sign in close proximity to the product. The sign measurements must be 2'x2' or, four sq. ft. in size and the vendor must be an HBAWMI member in good standing. Only members in good standing may advertise.
- h. Non-Members are not permitted to advertise on the premises of a Parade Home. Builder/Remodeler will be fined for non-members that advertise at their home and advertising will be removed. Non-Members are also not allowed in the Parade of Homes Guidebook advertisements. Contact the office with any questions or visit www. KalamazooHomePage.com for a complete list of HBAWMI members.
- 10. Directional signs, all other provided signs, shoe covers, and Parade Guidebooks will be available for pick up between Tuesday, June 7, 2016 and Thursday, June 15, 2016 at the HBAWMI office between 8:00 am and 5:00 p.m. Signs must be in place by Noon on Thursday, June 16, 2016.
- 11. Commercial entries with pools: Notify the HBAWMI if there is a pool on the premise. Pool areas must be locked/secured from the public areas of the house. Pools must not be used during Parade hours.

- 12. The Builder/Remodeler understands that the Guidebook Publisher and its representatives are prohibited from soliciting and collecting money for co-op ads in the Parade Guidebook. Parade Builder/Remodelers are responsible for making their own arrangements and collecting from their suppliers for co-op ads.
- 13. Non-members are not allowed to appear or advertise in the Parade Guidebook co-op ads. In the case of a manufactured Parade home, no logo may appear on the Builder/Remodeler page. The manufacturer may be mentioned in the copy on the builder page.
- 14. Builder/Remodeler may post a sign in their Parade Home stating that they do not wish the Parade Home to be photographed or videotaped by the public.
- 15. Any home may be photographed and used for promotion by the HBAWMI without further written permission of the Remodeler.
- 16. The final decision on all matters of policy of the 2016 Parade of Remodeled Homes shall be made by the Committee. The Builder/Remodeler understands that if the Commercial property is not completed by **8:00 a.m. Thursday, June 16, 2016,** or if the Builder/Remodeler violates any of the terms of this Contract, then the following penalties shall apply to the Remodeler:
- a. All of the fees which have been or will be paid by the Remodeler, including the Entry Fee and Performance Fee, shall be forfeited in full to HBAWMI; if the Remodeler has not paid such fees, then the same shall be due to HBAWMI. b. The Committee has the right to cancel the Builder/ Remodeler's participation in the Parade of Homes for up to one (1) year, which shall include the right of the Committee to cancel Remodeler's current participation in the 2016 Parade of Remodeled Homes (even if the Parade of Homes has commenced), or Remodeler's participation in the 2017 Parade of Homes. By signing this Contract, the Builder/Remodeler understands that HBAWMI is a non-profit trade organization and that participation in the Parade of Homes is a privilege and not a right; thus, Builder/Remodeler accepts and agrees that all decisions by HBAWMI related to this Contract shall be final and non-appealable. The Builder/Remodeler waives any and all alleged claims and causes of action against the HBAWMI, its employees, agents, or representatives, related to any alleged losses, damages, or expenses resulting from any HBAWMI decision, as are set forth in this Contract.
- 17. HBAWMI will not be liable for any loss or damage to houses, property or person(s) for any cause what so ever that may arise from the Builder/Remodeler's participation in the 2016 Parade of Homes. The Builder/Remod-

eler agrees to indemnify, defend and hold HBAWMI harmless, including its agents, representatives, and employees, from all claims, causes of action, damages, or expenses, of any nature, related directly or indirectly to the Builder/Remodeler's participation in the 2016 Parade of Homes. This includes, but is not limited to any damages, costs or expenses incurred by Builer/Remodeler, or any other person for all damages to any person(s) or property, or any decision by HBAWMI to enforce any of the rules under this contract.

- 18. The failure of HBAWMI to complain of any act or omission on the part of Builder/Remodeler, no matter how long the same may continue, shall not be deemed to be waiver by HBAWMI of any of its rights here under. No express waiver by HBAWMI, at any time, of any breach of any provision of this contract shall be deemed a waiver of a breach of any provision of this Contract or consent to any subsequent breach of the same or any other provision.
- 19. REFUND OF PERFORMANCE FEE: Remodeler understands that Builder/Remodeler will be refunded an amount up to \$500.00 if Builder/Remodeler complies with the following:
- a. Builder/Remodeler complies with all publicity rules.
- b. Builder/Remodeler's home is complete and clean by 12 p.m. on Thursday, June 16, 2016.
- c. Builder/Remodeler provides adequate access to the house (convenient parking, turnarounds, and/or shuttle).
- d. All rules and regulations of the 2016 Parade of Homes Contract.
- 20. Performance Fee refunds will be made in July 2016.
- 21. All refund/withdrawal requests must be made in writing. Full refund may be given if requested by March 31, 2016. A 50% refund may be given if requested by April 15, 2016. No refunds will be given after April 15, 2016. Late entries waive the right to any refunds.
- 22. Builder/Remodeler may request a variance for any of the above rules by submitting a written explanation to the Parade of Homes Committee by March 4, 2016. The Parade of Homes Committee will review all requests at the March 2016 Committee meeting. Builder/Remodeler may appear in front of the Committee to explain the hardship. Builder/Remodeler will be notified of the Committees' decision the following day. All decisions of the Committee are final.
